The Defendant above named having committed the crimes of BURGLARY (Category B Felony - NRS 205.060); FIRST DEGREE KIDNAPPING (Category A Felony - NRS 200.310, 200.320); SEXUAL ASSAULT WITH A MINOR UNDER FOURTEEN YEARS OF AGE (Category A Felony - NRS 200.364, 200.366); and COERCION SEXUALLY MOTIVATED (Category B Felony - NRS 207.190, 207.193), in the manner following, to-wit: That the said Defendant, on or about the 31st day of December, 2012, at and within the County of Clark, State of Nevada,


COUNT 1 - BURGLARY

did then and there wilfully, unlawfully, and feloniously enter, with intent to commit a felony, to-wit: sexual assault, that certain building occupied by [REDACTED], located at CIRCUS CIRCUS HOTEL & CASINO, 2880 South Las Vegas Boulevard, Room No. 613, Las Vegas, Clark County, Nevada.

COUNT 2 - FIRST DEGREE KIDNAPPING

did wilfully, unlawfully, feloniously, and without authority of law, lead, take, entice, carry away or kidnap [REDACTED], a minor, with the intent to keep, imprison, or confine said [REDACTED], from his parents, guardians, or other person or person having lawful custody of said minor, or with the intent to hold said minor to unlawful service, or perpetrate upon the person of said minor, any unlawful act, to-wit: sexual assault.

1 COUNT 3 - SEXUAL ASSAULT WITH A MINOR UNDER FOURTEEN YEARS OF
2 AGE

3 did then and there wilfully, unlawfully, and feloniously sexually assault and subject
4 ██████████, a male child under fourteen years of age, to sexual penetration, to-wit: anal
5 intercourse, by placing his penis into the anal opening of the said, against his will, or under
6 conditions in which Defendant knew, or should have known, that the said ██████████
7 was mentally or physically incapable of resisting or understanding the nature of Defendant's
8 conduct.

9 COUNT 4 - SEXUAL ASSAULT WITH A MINOR UNDER FOURTEEN YEARS OF
10 AGE

11 did then and there wilfully, unlawfully, and feloniously sexually assault and subject
12 ██████████ a male child under fourteen years of age, to sexual penetration, to-wit:
13 fellatio, by placing his penis on or in the mouth of the said ██████████, against his will,
14 or under conditions in which Defendant knew, or should have known, that the said ██████████
15 was mentally or physically incapable of resisting or understanding the nature of
16 Defendant's conduct.

17 COUNT 6 - COERCION SEXUALLY MOTIVATED

18 did then and there, wilfully, unlawfully and feloniously use physical force, or the
19 immediate threat of such force, against ██████████, with intent to compel him to do, or
20 abstain from doing, an act which he had a right to do, or abstain from doing, by blocking the
21 said ██████████'s exit and/or by struggling and pushing him back, preventing him from
22 leaving, one of the purposes for which the Defendant committed the offense was Defendant's
23 sexual gratification.


