I N F O R M A T I O N

THE UNITED STATES ATTORNEY CHARGES:

COUNT 1

On or about October 19, 2009, in the Southern District of Ohio, the defendant, **ABDULLAH M. MUSLIM**, also known as Johnnie P. Clagg, having been convicted of at least three crimes punishable by imprisonment for a term exceeding one year, namely:

(1) Making Threatening Communications, a felony in violation of Title 18, United States Code Section 871, on or about October 26, 1999, in the Southern District of Ohio, Case no. 1:98cr106;

(2) Felonious Assault, a felony in violation of Ohio Revised Code (O.R.C.) 2903.11, on or about February 14, 1994, in the Franklin County Court of Common Pleas, Case number 93CR-2407; and,

(3) Carrying a Concealed Weapon, a felony in violation of O.R.C. 2923.02, on or about August 30, 1991, in the

Franklin County Court of Common Pleas, Case number 91CR-05-2639,

did knowingly possess in or affecting commerce, the following firearms:

(1) Arsenal 7.62 Assault Rifle, Model SA M-7, serial number AB021619;

(2) Intratec 9mm pistol, Model AB-10, serial number A011186;

(3) AK 47, 7.62, serial number STG 2000-c, serial number G088806.

In violation of 18 U.S.C. § 922(g)(1) and § 924(a)(2).


COUNT 2

On or about the 19th day of October 2009, in the Southern District of Ohio, **ABDULLAH M. MUSLIM**, also known as Johnnie P. Clagg, knowingly possessed destructive devices, namely, a combination of parts, namely 5 metal threaded pipes, 10 metal end caps, 4 cans of 2-F black powder, and two rolls of fusing, designed and intended for use in converting said parts into 5 pipe bombs, which are firearms and destructive devices, as defined by 26 U.S.C. §5845(f)(3) capable of causing death or serious bodily injury,

said destructive devices not registered to him in the National Firearms Registration and Transfer Record as required by 26 U.S.C. §5841.

In violation of 26 U.S.C. §5861(d) and §5871.
